All entries are accepted with the understanding that Erie County Fair Horse Show will not be held responsible for any loss, damage or injury to any horse exhibited or any article of any kind. All horses shall be under the control and direction of the show committee but solely at the risk of the exhibitor who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, his agents or employees, or by any animal owned or exhibited by him, and shall indemnify against any and all damages and liability thus occasioned, including attorney fees, which may be incurred as a result thereof. The submitting of an entry form to the Show Secretary shall constitute an acceptance by each person signing same of the provisions herein set forth. Every entry at a recognized show shall constitute an agreement that the person making it, owner, lessee, trainer, manager, agent, coach, driver, rider and horse shall be subject to the rules of the association, the local rules of the show. It shall further constitute that every horse, rider and/or driver is eligible as entered and that the owner and any of his representatives are bound by the constitution and rules of the show.
